## **COMPLIANCE VIOLATIONS**

**EXPIRED INSPECTION**

This violation may be dismissed if the inspection sticker was not expired for more than 60 days and a copy of your receipt that shows that the vehicle passed inspection is submitted to the Court along with a \$20 dismissal fee is submitted to the Court by the

appearance date on the bottom of your citation. No extensions to submit the proof will be granted once the appearance date has passed you will be responsible for the full fine amount of \$143.

#### EXPIRED REGISTRATION

This violation may be dismissed if the vehicle registration is renewed and the **penalty fee was paid to the tax assessors office**, and a copy of the registration receipt and \$20 dismissal fee is submitted to the Court by the appearance date on the bottom of the citation. **You must notify the tax assessor before payment of renewal that you have received a citation in order to pay the penalty fee.** No extensions to submit the proof will be granted once the appearance date has passed you will be responsible for the full fine amount of \$110.

#### EXPIRED DRIVERS LICENSE

This violation may be dismissed if you renew your driver's license and submit proof of renewal and \$20 dismissal fee to the Court by the appearance date on the bottom of the citation. No extensions to submit the proof will be granted once the appearance date has passed you will be responsible for the full fine amount of \$168.

#### FAIL TO DISPLAY DRIVERS LICENSE

This violation may be dismissed if a copy of a valid drivers license and \$10 dismissal fee is submitted to the Court by the appearance date on the bottom of the citation. No extensions to submit the proof will be granted once the appearance date has passed you will be responsible for the full fine amount of \$168.

#### FAIL TO CHANGE NAME OR ADDRESS ON DRIVERS LICENSE

This violation may be dismissed if proof that you changed your name or address and \$20 dismissal fee is submitted to the Court by the appearance date on the bottom of the citation. No extensions to submit the proof will be granted once the appearance date has passed you will be responsible for the full fine amount of \$110.

#### FAIL TO MAINTAIN FINANCIAL RESPONSIBILITY

This violation may be dismissed if proof of a **valid** insurance policy for the date and time that the citation was issued is presented to the Court by the appearance date on the bottom of the citation. All insurance documents not submitted directly from an insurance agency will be required to be verified for validity on the date and time of the violation. If your insurance agent submits the information either by mail or by faxing to 940-627-1822 and referencing your citation number this will not require additional time to verify.
